National Visa Center: After petition approval, the National Visa Center (NVC) handles processing for certain kinds of documents, sending them onward to U.S. Embassies & Consulates.

Civil Documents - Travel

Once you submit your fees, forms, and supporting documents to NVC, we will review your case to ensure you provided all the documentation required to schedule the immigrant visa interview. Interviews are based on the availability of appointments offered at the Embassy/Consulate.

NVC Processing - Travel

IMPORTANT: Do not send any documents to NVC by mail. However, you must bring every civil document you uploaded and submitted with your application to your visa interview. To submit documents, log into CEAC and go to the “Start Now” buttons located under Affidavit of Support Documents and Civil Documents. When you have uploaded all the required documents for each section, press “Submit Documents”.

Submit Documents - Travel

Note: If you choose to use a public computer, be sure to delete your scanned documents once you have finished uploading them. Unless specifically directed to do so by the National Visa Center (NVC) please do not mail any documents to NVC. If you do, you will delay the processing of your case and risk losing any documents you send.

Scan Documents - Travel

Before the National Visa Center reviews your case, you must pay all fees and submit all required documents, such as: Petitioner's Affidavit of Support; Supporting financial documents; Applicant's DS-260, and; Applicant's civil documents. Required documents vary based on petition type.

NVC Timeframes - Travel

Next, the NVC will send the U.S. family member petitioner a bill

for the Affidavit of Support review (\$120 as of 2020) and send either the immigrant or agent a bill for the immigrant visa processing fee (\$325 per immigrating family member—2020 figure). Once the fees are paid, the immigrant must submit Form DS-260, the online immigrant visa application.

Forms and Documents Needed for a Family Immigrant Visa at ...

When an applicant's priority date is close to becoming current, you will pay the Affidavit of Support (AOS) processing fee and Immigrant Visa Application Processing Fee (IV Fee). NVC fee payment details; Complete Affidavit of Support Form Once the Affidavit of Support Fee (I-864 processing) fee is paid, NVC will send the I-864 forms and instructions to the petitioner. Instead of NVC sending you the actual forms, you may be asked to download them. In that case, download them and complete them.

USA Immigrant Visa Process - Consular Processing

The National Visa Center (NVC) is responsible for collecting visa application fees and supporting documentation. The NVC will notify the petitioner and you (the beneficiary) when the visa petition is received and again when an immigrant visa number is about to become available.

Consular Processing | USCIS

Immigrant Visa On Saturday October 31, between 6:00 p.m. until 10:00 p.m. (Washington, D.C. time), CEAC will not be available due to scheduled maintenance. This maintenance is expected to be completed by 10 p.m. but may be extended beyond this time.

All documents must be current on the appointment date. Any expired documents may delay the processing of the visa. If your documents were issued more than one year prior to the interview date, they are considered expired. In such cases, you must bring updated documentation with you to your interview at the Consulate.

Required Documentation For Immigrant Visas | U.S. Embassy ...

The NVC performs immigrant visa pre-processing, including collecting visa fees, forms, and documents from sponsors (petitioners) and immigrant visa applicant (s). Therefore, it is important to await contact from the NVC for next step instructions before you pay fees or submit any forms or documents.

NVC | After Your Petition is Approved

Begin National Visa Center (NVC) Processing: After U.S. Citizenship and Immigration Services (USCIS) approves your application, it is sent to NVC. It may take up to 8 weeks for NVC to receive and process your application. After processing your application, NVC will assign you a case number.

Visa Status Check - United States Department of State

For most U.S. Embassies and Consulates General, the National Visa Center (NVC) provides document collection and review, and schedules the cases for interview. The Department of State refers to these embassies and consulates as Appointment Posts. For immigrant visa cases assigned to an Appointment Post, the NVC will collect the fees, affidavit of support, civil documents, and police certificates, as required.

NVC collects visa application fees together with supporting documentation, and when an applicant's immigrant visa number is likely to become current, it starts and completes the processing of the applicant's case. At this stage, you must submit the immigrant visa processing fees together with supporting documentation.

First, you will get an “Immigrant Visa Application Processing Fee Bill Invoice” from the NVC for each person in your family that is doing IVP. The invoice will indicate the processing fee (“Amount Due”) and will provide payment instructions. Please follow the instructions very carefully.
