### **Perspective: Writing Clear, Effective Police Reports - No ...**

The answer is that this is a “Just the facts, Ma’am” report. There’s no investigation (Type 2) or intervention (Type 3). In a Type 1 report, you interview a witness or victim and write down the information – and you’re finished. You might write a Type 1 report after a citizen reports that her bicycle was stolen.
