All private investigators, private patrol operators and private investigation companies seeking to obtain or retain a license under the provisions of the Private Investigations Act shall file with the department and retain in full force and effect, a surety bond in the amount of ten thousand dollars (\$10,000) executed by a surety company authorized to do business in this state on a form prescribed by the department.

How To Get a Private Investigator License in New Mexico

The Department of Public Safety (DPS) regulates the private security profession in Texas. DPS protects the public by conducting fingerprint-based background checks on applicants, investigating and resolving complaints, and taking disciplinary action against licensees or seeking criminal prosecution of those who perform private security services without a license.

TxDPS - Private Security Program

Private Investigators must show they can perform their duties in an unbiased manner while adhering to the highest standards of ethics and integrity. They must also show they can determine if an investigation request is lawful.
